- Have excellent research, writing and oral presentation skills.
- Experience with detailed statutory and regulatory analysis
- Be comfortable with and have experience making presentations to a wide range of audiences.
- Be willing to work in collaboration with health consumers, businesses and health care providers.
- Be an independent and creative thinker and work well as part of a team.
- Be capable of developing and maintaining relationships with a wide variety of policy makers, stakeholders and constituencies.

Qualifications - Preferred:

- Graduate or law degree.
- Experience working with state and/or federal lawmakers.
- Quantitative research skills.
